

# Applicable tax rate for sales of solar container products

Does 0% VAT apply to solar panels?

Will VAT be abolished in the Netherlands in 2026?

The Dutch government has plans to abolish as of 2026 the reduced VAT rates for providing accommodation and for certain cultural goods and services. In the Netherlands, the standard VAT rate is 21%. There are two additional special rates: the 9% rate and the 0% rate (zero rate).

What is the VAT rate in the Netherlands?

The Dutch VAT regime (btw, omzetbelasting) has 3 rates : 0%, 9% and 21%. In some instances businesses are exempt from VAT and in some cases there are special arrangements regarding VAT. If you are based in the Netherlands and you do business in other countries, the 0% VAT rate may apply.

Do you pay VAT on solar panels?

Then you do not pay VAT (in Dutch) for the solar panels, parts, and installation. You use part of the electricity generated by your solar panels yourself. What remains, you feed back to the electricity grid. If you feed more back than you use, you will receive compensation from your energy supplier.

What is the VAT rate for solar panels in Portugal?
