The climate is pleasant, moderated by the southeast trade winds for about nine months of the year and with moderate rainfall. Tropical cyclones

Cocos (Keeling) Islands is recommended, to support P-8 Poseidon maritime aircraft, thus exploiting only a small fraction of the actual strategic potential of either location. Discovered in 1609, the Cocos Islands were initially a privately owned asset, granted to the Clunies-Ross family in perpetuity by Britain in 1886,

The Cocos (Keeling) Islands are a group of 27 islands, and are composed of 2 atolls: North Keeling, and South Keeling. South Keeling consists of 26 islands in a horseshoe formation around a large lagoon (approximately 10 km across).
