What is the trade value of Guadeloupe?

The total value of exports (FOB) is US\$ 162 million. The total value of imports (CIF) is US\$ 1,901 million. At the HS6 digit level, 762 products are exported to 53 countries and 3,237 products are imported from 134 countries. What is the product share of Guadeloupe capital goods?

Guadeloupe Capital goods exports are worth US\$30 million, product share of 18.24%. Guadeloupe Capital goods imports are worth US\$374 million, product share of 19.67%. Hirschman Herfindahl Market concentration index is 0.69. Index of export market penetration is 0.69.
