St. Kitts and Nevis will add a utility-scale solar and storage plant to meet one quarter of its electricity needs. The 35.6MW solar park and 44.2MWh battery storage facility will be built and operated by Leclanche, a Swiss firm acting as EPC contractor.

St. Kitts was once known as the Gibraltar of the West Indies for its domination of 18th-century colonial battles. How the island rose to become the world's leader in sugarcane cultivation, an inspiration for the industrial revolution in the process.

Construction has begun on a solar-plus-storage project on the Caribbean island of St. Kitts & Nevis, backed by Leclanche, Solrid and MPC Energy Solutions. The launch of the SOLEC power plant is nearly 18 months later than expected with the start of construction first announced back in December 2020, covered by Energy-Storage.news.

The solar panels collect sunlight that is converted into electricity. The solar project on St. Kitts will be oversized, allowing a portion of that electricity to meet current electric demand on the island, and the remainder to charge the large-scale battery storage system to meet island demand after the sun sets.
