What are the provisions of the Swaziland Employment Act?

5. Act binds Government Subject to section 6, the provisions of this Act shall apply to employment with, by, or under the Government, other than to employment in the Royal Swaziland Police Force, the Umbutfo Swaziland Defence Force and the Swaziland Prison service.

Who can enter into a contract of employment in Swaziland?

(1) This Part of the Act shall apply in respect of every contract of employment made within Swaziland and to be performed wholly within Swaziland. (2) Any person, of or above the age of fifteen years, may enter into a contract of employment other than a foreign contract of employment. 22.

What is a temporary licence in Swaziland?
