Is the Vatican City State a member of the ICC?

The Vatican City State is not a member of the International Criminal Court (ICC). In Europe, only Belarus is also a non-party, non-signatory state, while Ukraine and Monaco are signatory states that have not ratified and Russia withdrew from it in 2016. The Vatican City State is not a member of the European Court of Human Rights.

What is the legal system of the Vatican City State?

This chapter examines the legal system of the Vatican City State, probably the most particular among those of the "small states": not only for the minimal territorial dimensions and the absence of a real stable population, but above all for its original and functional connection with the Holy See, or rather with the Catholic Church.

What is a Vatican City State?

As governed by the Holy See, Vatican City State is an ecclesiastical or sacerdotal - monarchical state ruled by the Pope, who is the bishop of Rome and head of the Catholic Church. The highest state functionaries are all Catholic clergy of various origins.

What does a Vatican Secretary of State do?

He oversees the execution of laws and the adoption of other legislation and implements the President's decision and directives. (Article 16 of the Fundamental Law of Vatican City State of 13 May 2023). VICE SECRETARY GENERAL

What is the most important characteristic of the sources of Vatican law?

This is the actual reason for the most important characteristic of the sources of Vatican law that we are going to analyse: the direct incorporation of Canon Law, that is described in Article 1 of the Law on the Sources of Law, promulgated by Benedict XVI on 1 October 2008 (which repeals the 1929 Law).

What is the citizenship of Vatican City based on?

Unlike citizenship of other states, which is based either on jus sanguinis (birth from a citizen, even outside the state's territory) or on jus soli (birth within the territory of the state), citizenship of Vatican City is granted on jus officii, namely on the grounds of appointment to work in a certain capacity in the service of the Holy See.
